If transdermal (TD) estradiol gel is the right choice, discuss both available options

Both are PBS listed

Sandrena® offers her:

▶ ***a higher concentration of estradiol***

Sandrena has 1 mg of estradiol per gram of gel. The other TD gel has 0.6mg of estradiol per gram of gel.^{4,5}

▶ ***a lower volume of gel to apply to her body***

The recommended starting and standard dose of Sandrena is 1 gram of gel. The recommended starting and standard dose of the other TD gel is 2.5 grams of gel.^{4,5}

▶ ***a smaller application area***




Sandrena's recommended application area should be one to two times the size of the hand for all doses (0.5g, 1.0g and 1.5g). The application area for the other TD gel should be as large as possible.^{4,5}

▶ ***accurately measured single dose sachets⁴***

Women with an intact uterus should combine Sandrena with an adequate dose of progestogen. They may choose from a Mirena®, Prometrium® or any other available progestogen.^{3,4,5}

Sandrena offers her three available doses for individual titration

- ▶ Sandrena is available in 0.5g and 1.0g sachets for accurate dose modification across the three TGA-approved doses: 0.5g, 1.0g and 1.5g
- ▶ Each sachet is applied once daily to the skin on the lower trunk or thigh.⁴
- ▶ After application the gel should be allowed to dry for a few minutes and not be washed for one hour.⁴
